



Telstra's Restructure Supplier information pack

On 1 January 2023, as part of Telstra's legal restructure, the contract/s you have with Telstra Corporation Limited may be transferring to a new Telstra Group entity, **Telstra Limited**. After 1 January 2023, you may also start receiving Purchase Orders from different Telstra Group entities.

This pack aims to set out the new company information you will need as a supplier of Telstra to update your systems.

The changes advised in this pack come into effect on 1 January 2023.

Please continue to use all current contact, payment, and banking information for Telstra Corporation Limited until 31 December 2022.

About Telstra's Restructure

As we have previously informed you, Telstra is undertaking a legal restructure that includes a new holding company (Telstra Group Limited), new subsidiaries, and the transfer of certain assets (including supplier contracts) to the new subsidiaries.

Your contracts/agreements with Telstra Corporation Limited

As a supplier to Telstra Corporation Limited, you will have received a notice from us informing you of one of the following:

1. Your contract/s are **transferring to Telstra Limited** as part of our legal restructure on 1 January 2023.
2. Some (or all) of your contract/s are **staying with Telstra Corporation Limited**.
3. All of your contracts are transferring to Telstra Limited as part of our legal restructure on 1 January 2023 unless we contact you about them being novated separately to one of our new **international entities**.

How does the transfer work? Do we need a formal contract novation?

For contracts transferring to Telstra Limited as part of our legal restructure, there's no need for any formal contract novations.

This is because the contracts will be transferred via a legislative Scheme of Arrangement under section 413 of the Corporations Act 2001, so a court order will legally ensure the contracts are transferred from Telstra Corporation to Telstra Limited on 1 January 2023.

Contracts that are being transferred outside of the Scheme of Arrangement (e.g. to certain Telstra International entities) will be novated separately.

How to get ready for 1 January 2023

What you need to do – before 1 January 2023

Update your systems

You will need to update your internal systems for future invoicing to reflect:

- **For contracts transferring to Telstra Limited**, the new Telstra Limited company name and ABN, effective 1 January 2023.
- **For contracts being novated separately to certain Telstra International entities**, the relevant entity name(s) and information, effective from the date of novation.

We have provided entity information in the next section of this pack to help you update your systems. Please let us know if you need any additional details.

If you have an open purchase order and/or statement of work with Telstra Corporation Limited

Please ensure you submit any outstanding invoices for your open purchase orders or statements of work to the current Telstra Corporation Limited (ABN 56 650 620 303) no later than 16 December 2022 to ensure they are paid on time.

What you need to do – after 1 January 2023

- **Invoicing:** Ensure your invoices are addressed to the same entity that is on your purchase order.
- **Purchase Orders from other Telstra Group entities:** If your contract allows for purchasing by Telstra Group Entities, you may start to receive purchase orders from some of the entities in this pack. If so, you will need to update your internal systems to reflect their information. If you need any additional details other than what is set out in this pack, please let us know.
